Pursuant to Regulation 30 read with Part A (B) of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, this is to inform that Ircon International Limited (IRCON) has emerged as the lowest bidder for Construction of 8-Lane Access Controlled Expressway (Bhoj to Morbe Section-SPUR of Vadodra Mumbai Expreesway) in the State of Maharashtra on Hybrid Annuity Mode under Bharatmala Pariyojana (Phase II- Package XVII). The project was floated by National Highways Authority of India on competitive bidding and value of the project is approx. Rs.1436 Crore (Bid Project Cost). The completion period of the project is 2.5 years.

This work will be undertaken & executed by a Special Purpose Vehicle ("Concessionaire" as a limited liability company) which shall be incorporated by IRCON as its Wholly-Owned Subsidiary Company.
