- 2. Candidates have to bring the following <u>original documents</u> at the reporting at Corporate Office:
- **i.** Matriculation Certificate (for age proof).
- ii. Certificate of Degree and marksheets as per eligibility criteria. Candidates, who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion factor as applicable to percentage as prescribed by the University/Institute.
- iii. Certificates in proof of experience, clearly indicating the length and line of experience as per eligibility conditions. Certificate/proof submitted in support of experience should clearly mention the date of joining & relieving. Offer letter alone will not be considered as proof of experience, the candidate should submit acceptable proof of joining & relieving.
