- (vi) One Photo-identity-card like Aadhaar Card, Driving-license, Passport or any other valid document with you for identification
- (vii) Candidates serving in Central/State Government/ Public Sector Undertaking including Public Sector Banks/Autonomous Bodies etc. Including Departmental candidates are required to produce a "No Objection Certificate" from their present employer at the time of interview in original failing which, he/she will not be allowed to appear in the interview.

- (ix) Latest passport sized photograph.
