- (ii) Degree and Mark sheets of all the semester/year of Minimum Education Qualification (MEQ) prescribed in the Advt. **Candidates who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion formula as applicable to percentage as prescribed by the University/Institute.**
- (iii) Certificates of other professional qualifications, **Certificates in proof of experience, as applicable,**

**clearly projecting the requisite experience indicating the length and nature of experience and work done, as per eligibility conditions/criteria.** Certificate/proof submitted in support of experience should clearly mention the date of joining & relieving. **Offer letter alone will not be considered as proof of experience**, the candidate should submit acceptable proof of joining & relieving.

- (iv) One Photo-identity-card like Aadhaar Card, Driving-license, Passport or any other valid document with you for identification
- (v) Complete set of self-attested photocopies of all the above mentioned certificates.
- (vi) Latest passport sized photograph.
- (vii) Failure to adhere to above may lead to cancellation of the candidature. The interview of such candidates may be held at discretion of IRPL Management. No claim whatsoever in case of cancellation of candidature/ non-interview (due to non-adherence as mentioned above) shall be entertained.

**General Instructions:**

- (i) The candidates are once again advised to check their eligibility thoroughly before appearing for the interview to avoid disappointment at later stage. If any discrepancies are found at any stage of the recruitment process, the candidature of the candidate will be immediately cancelled.
