NOTICE INVITING TENDER

General Manager/J&K-I, IRCON International Limited (IRCON in abbreviation), Palika Bhawan, Sector-13, R.K. Puram, New Delhi-110066 invites **sealed Limited tenders** on prescribed forms from the **short listed agencies only** for execution of the following work:

- 1.0 Tender documents can be obtained from 10.30 hours to 16.00 hours on all working days from **18.03.2010 to 29.03.2010** from the office of General Manager/J&K-I, IRCON International Limited, Palika Bhawan, Sector-13, R.K. Puram, New Delhi-110066, on payment (non-refundable) of Rs.5000/- in cash or Demand Draft/Pay order drawn in favour of IRCON International Limited, Payable at Delhi towards the cost of one set of the tender documents. Tender documents can also be obtained by post, for which an amount of Rs.500/- shall be charged extra. IRCON International Limited shall not be responsible for any postal delay in receiving the tender documents. The tender documents shall be sold only to the persons authorized in writing by the firm, company or Joint venture. Tender document can also be downloaded from IRCON's web site **www.ircon.org** in such a case, the tenderer shall deposit the cost of tender documents (Non-refundable) alongwith the submission of the tender, failing which his tender shall not be opened. The cost of tender documents shall be deposited in the form of demand draft / pay order in favour of IRCON INTERNATIONAL LIMITED, New Delhi and enclosed in the envelope containing the Earnest Money Deposit. Tenderer(s) are advised not to make any corrections, additions or alterations in the downloaded tender documents. If any

such corrections/additions/alterations in the downloaded tender documents are made, such tender shall not be considered.

- 2.0 Completed tender documents sealed properly in envelopes super-scribing with the name of the work. These sealed envelopes and the envelop (super-scribing “Earnest Money for the work” containing the Earnest Money) in the form as prescribed in the tender documents shall further be sealed in a larger envelope super-scribing the name of the work as stated above (alongwith date and time of opening of tenders) which should be deposited in the tender box at IRCON’s office at address given in Para 1.0 before **15.00 hours** of **30.03.2010**. Tenders shall be opened at 15:30 hours on the same day in the presence of the tenderers or their authorized representatives intending to attend the opening. Tenders duly sealed in the prescribed manner above can also be sent through Registered Post/Speed Post/Courier so as to reach in this office not later than the time and date of opening of tenders. Any tender received later than the time and date of opening of tenders shall be rejected and returned to the tenderer unopened.
- 3.0 Tender shall be submitted as per “Instructions to Tenderers” forming a part of the tender document.
- 4.0 Any tender received without Earnest Money in the form as specified in tender documents shall not be considered and shall be summarily rejected.
- 5.0 IRCON reserves the right to postpone the tender submission/opening date and to accept/reject any or all tenders without assigning any reasons thereof. IRCON’s assessment of suitability as per eligibility criteria shall be final and binding.
- 6.0 Tenderers may note that they are liable to be disqualified at any time during tendering process in case any of the information furnished by them is not found to be true. EMD of such tenderer shall be forfeited. The decision of IRCON in this regard shall be final and binding.
- 7.0 The validity of the offer shall be 90 days from the date of opening of the tender.
- 8.0 The transfer of tender documents purchased by one intending tenderer to another tenderer is not admissible. Tenderer can submit tenders only on the documents purchased by him.
- 9.0 The scope of works includes Hiring of vehicles for Ircon Officer & Staff for project work of Quazigund-Baramulla New BG Rail Line Project for the period 01.04.2010 till 31.03.2011
- 10.0 In case of any disputes/differences, the jurisdiction shall be Delhi courts only.
