

Subject: Disposal of Old Computer Items .

Sir,

Ircon International Limited intends to dispose off "Old and Obsolete Computers, Notebooks, printers, etc" on as is where is basis as per the details and terms – conditions given below. The reserve price for the whole lot is Rs1,53,350/- plus 4% VAT and Earnest Money Deposit (EMD) is Rs.5000/- payable through DD favoring Ircon International Ltd. payable at N.Delhi. Terms and conditions:

Payment : Through Demand draft(DD) drawn in favour of "Ircon International Limited" payable at New Delhi to be arranged within 7 days of date of disposal order issued by Ircon International Ltd..

Validity of bid : 30 days from the date of opening of bids.

Delivery : Within 7 days after submission of DD favoring Ircon International Ltd. Successful bidder will be responsible for transportation of whole lot from Ircon office at his/her own cost within 7 days (excluding Saturday/Sunday & gazetted holidays) failing which a rent of Rs.1000/- per day will be charged till the date of transportation of whole lot from Ircon office.

Date of submission : Offer in sealed cover superscribed on top "Bid for Disposal of Old Computer Items" should reach undersigned on or before 26/04/10 up to 1500 hrs which will be opened at 1530 hrs. on same date in presence of bidders representatives.

Price Quoted : Price quoted should be firm and should be all inclusive. Ircon will not pay any other charges to the bidder. However, Ircon will charge 4% VAT on the quoted price.

EMD : The bidder must furnish Earnest money as specified above failing which the tender shall be summarily rejected. No interest shall be allowed on EMD.EMD of bidder shall be forfeited if he withdraws his bid during the period of bid validity. EMD of successful bidder is liable to be forfeited if he fails to deposit the offered price by DD within 7 days of placing disposal order. In case of forfeiture of EMD, bidder shall be debarred from bidding in case of re-invitation of tender.

Other Special Conditions

- Bid received late will not be considered
- All the items will be sold in one lot only
- Price quoted should be for the whole lot of all the items mentioned in Annexure 'A'.

- All the items are being sold on “As is where is basis”, hence Ircon International Ltd. will not be liable for any defect or their working conditions.
- EMD of unsuccessful bidders shall be discharged and returned as promptly as possible. EMD of successful bidder shall be adjusted against the offered price & balance amount to be deposited within the time specified above.
- Items once sold will not be taken back.
- Ircon International Ltd. reserves the right to accept/reject any or all bids without assigning any reason.
