Age Criteria: Candidate should be preferably below 55 yrs of age.

Medical Standards: Candidates should be in sound health and free from color blindness. No relaxation in health standards will be allowed.

Compensation Package:

For immediate Absorption: Basic Pay, DA, HRA/ Lease, Liberal Medical including indoor medical benefits for self and dependents, LTC, Advances, Gratuity, EPF, Performance Related Pay (PRP), Transport Assistance, Holiday-Homes, Welfare schemes and other Fringe benefits as per rules of the Company.

For Deputationsists: Expert Professional Allowance – 15%, Medical Allowance (Outdoor) – 4%, Lease/HRM, Deputation Allowance etc and other perks as per rules of the company.

Copies of APAR for last 03 yrs:

For candidates applying on Deputation Basis in IRCON, attested copies of APAR for last 03 yrs should be enclosed by the Forwarding Authority with the application

Place of posting: Anywhere in the Projects/Offices of the Company within India or abroad.

Surety Bond: Selected candidates have to execute a bond of Rupees 3 lakhs to serve the company for at-least three years (For candidates on Immediate Absorption basis)

Duration of appointment on Deputation: 3 years from the date of appointment which can be further extended upto 5 years

Selection Process: Interview

Suitability: If selection panel finds any candidate suitable/fit for a lower post/ grade, then he/she shall be selected on the lower post (irrespective of the actual post/vacancy to which candidate has applied) subject to the willingness of the candidate.

The number of vacancy indicated against each post are tentative. The same may increase / decrease depending upon the availability of suitable candidates. However, the overall number of Post shall remain same.

A -: GENERAL INSTRUCTIONS:-

1. Since candidate are presently working with Railways /PSU, they should inform their employers in writing before applying for any post in Ircon. **The applications of such applicants should either be forwarded through proper channel or they will have to produce NOC from their employers at the time of interview.**
2. **In the event of difficulty in getting NOC / Application Forwarded from their parent department, they may submit an undertaking at the time of interview that they will not claim any service transfer benefits / protection of pay in case of their selection on Immediate Absorption Basis. Such candidate will be selected on Minimum of the pay scale.**

The vigilance/ DAR clearance status should be clearly stated in the application format.

3. All information submitted in the application will be verified with original documents at the time of interview. If any information provided by the candidate is found to be false or incorrect or not in conformity with the eligibility criteria, then his/her candidature is liable to be rejected/cancelled at any stage of the recruitment process.
4. Any Corrigendum/ Addendum pertaining to the advertisement will be published on IRCON's Official Website only.

B -: INSTRUCTIONS FOR APPLYING:-

1. Before applying, candidates should ensure that they fulfill all the eligibility criteria mentioned in the advertisement.

2. Eligible candidates **have to apply in prescribed format through off line mode only.**

It is advisable that the candidates have a valid e-mail id in order to facilitate faster communication.

- e) Certificates in proof of experience, as applicable, clearly indicating the length and line of experience as per eligibility conditions;

- g) CTC/ Proof of Pay Scale/ Grade

4. After the application is filled duly, candidates must take a printout of the application form along with all the relevant documents as specified above and send it to above mentioned address.


