2. D&AR/Vigilance clearance of the applicant, in case not received with the forwarded application. In case D&AR/ Vigilance clearance is not conveyed it will deemed to be considered as No D&AR/Vigilance case is pending/ contemplated against the employee and to that extent Individual will have to give an undertaking.
3. Attested copies of Annual Performance Appraisal Reports (APAR) for the last 04 years, if not sent with the forwarded application.

**General Instructions:**
