## D. Directions for Eligible /Provisionally Candidates for Interview:

Based on result of Written Test, the successful candidates will be called for interview in the ratio of 1:10 in order of merit. The candidates are advised to bring their original testimonials as indicated below and against their names in **Table A** above, along with a photocopy, as these will be required for document verification prior to the interview:

- (i) Matriculation Certificate (for age proof);
- (ii) Self-Attested copy of Certificate of professional/academic Degree/diploma. Certificates of other professional qualifications, if any;

- (iii) Certificates in proof of experience, if any, as applicable, clearly projecting the requisite experience indicating the length and nature of experience and work done, as per eligibility conditions/criteria;
- (iv) Certificate in support of claim of belonging to Schedule Caste, Schedule Tribe and Other Backward Classes, PWD, Ex-serviceman, where applicable.
