Candidature of Shortlisted candidates for skill test is purely provisional subject to subsequent verification of original documents and also fulfilling the eligibility conditions as advertised.

**All Eligible candidates** as per the table I above are requested to bring their following original testimonials, along with a photocopy, for document verification on the day of document verification as per the schedule above:

- 1. Copy of System Generated Application
- 2. Matriculation Certificate (for age proof);
- 3. Self-Attested copy of Certificate of professional/academic Degree/diploma. The percentage obtained in Diploma/BE/B Tech/BSc(Engg) has to be calculated by considering marks obtained in all semesters/years. Also, necessary documents specifying the equivalence or CGPA conversion documents, wherever applicable.
- 4. Certificates of other professional qualifications, if any;
- 5. Certificates in proof of experience, if any, as applicable, clearly projecting the requisite experience indicating the length and nature of experience and work done, as per eligibility conditions/criteria. The experience certificate should clearly indicate the 'From' and 'To' date i.e. date of joining and date of relieving;
- 6. One Photo-identity-card like Aadhar Card, Driving-license, Passport or any other valid document with you for identification.
- 7. #### **DIRECTIONS FOR ELIGIBLE CANDIDATES REGARDING SKILL TEST:**

The skill test will be of 100 marks of 4 hrs duration and the test will have pre-dominant emphasis on Civil-Drafting in Auto CAD with 80 marks and 20 marks for Hindi/English language/General Knowledge. The minimum qualifying marks will be 60%.

#### **GENERAL INSTRUCTIONS:**
