**A. GENERAL CONDITIONS:**

1. Selection will be through written Exam and /or interview of shortlisted candidates.
2. If the number of candidates applied is more, the candidates will be shortlisted on the merit of marks secured in degree/diploma as per MEQ prescribed, and shall be called for written exam and/or interview. List of shortlisted candidates shall be published on our web-site.
3. The number of posts indicated above may vary based on further assessment of requirement.
4. The above posts are specifically for **Ircon's Dedicated Freight Corridor Project CTP-12, Mumbai- Surat/Valsad** and not for the regular establishment of Ircon. The appointment will be initially for a period of one year, extendable further as per the requirements of the company, if the services of the candidates are found to be satisfactory. However, the appointment is co-terminus with the project for which is candidate is selected and will not confer any right to claim absorption in regular establishment of the company or for appointment in other projects of the company.
5. Applicants working in Govt./PSUs may note that they have to produce NOC at the time of interview and resign from their parent organization on or before joining.
6. Reimbursement for indoor treatment for self at the place of posting only would be permissible.
7. Minimum PF as prescribed under the EPF & MP Act 1952 will be deducted from the salary and a matching contribution will be made by IRCON. The accumulations will be paid at the time of cessation of contract.
8. One leave for each calendar month of service which can be availed during the contract period. Leave can be carried forward and accumulated but no leave encashment for unavailed leave is allowed during the contract or on resignation or termination of contract. No other type of leave would be admissible.
9. One weekly off and other public holidays when the project office remains closed would be available.
10. Working hours/days and off will be the same as for the Project.
11. TA/DA would also be admissible if deputed on outstation duty.
12. No other perks or benefits would be admissible except the above.
13. The ex-contractual employees of Ircon, whose services were terminated due to closure of projects, can also apply for these posts if they fulfil the required qualifications and experience. A copy of the termination letter should be sent along with the application. This appointment will be subjected to their satisfactory performance and shall be co-terminus with the project. The person so appointed for these projects will have no claim for their absorption in regular establishment of the Company or for appointment in other projects of the company.
