### **Selection Process: Interview**

**A** The above post is specifically for Ircon's Corporate Office at New Delhi, on contract basis and not for the regular establishment of Ircon. The appointment will be initially for a period of one year, extendable further as per the requirements of the Company, if the services of the candidates are found to be satisfactory.
