- III. Certificates of other professional qualifications, if any.
- IV. Certificates in proof of experience (clearly indicating the length, & nature line of experience as per eligibility conditions)

Candidates not accompanying the above mentioned original documents will not be allowed to appear in the Interview.

2. Eligible/ Provisionally Eligible officials need to bring the missing documents as mentioned against their names in the table (wherever applicable) failing which they will not be allowed to appear for the interview.

3. The candidates are once again advised to check their eligibility thoroughly before appearing for the interview to avoid disappointment at later stage. If any discrepancies are found at any stage of the recruitment process, the candidature of the candidate will be immediately cancelled.

4. IRCON shall be free to reject any application at any stage of the recruitment process, if the candidate is found ineligible for the respective post.
