- 2. Candidates have to bring the following **original documents** at the reporting at Corporate Office:
- i. Matriculation Certificate (for age proof).
- ii. Certificate of Degree and marksheets as per eligibility criteria. Candidates, who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion factor as applicable to percentage as prescribed by the University/Institute.
- iii. Certificates in proof of experience, clearly indicating the length and line of experience as per eligibility conditions. Certificate/proof submitted in support of experience should clearly mention the date of joining & relieving. Offer letter alone will not be considered as proof of experience, the candidate should submit acceptable proof of joining & relieving.
- iv. Community certificate (SC, ST, OBC & EWS etc.), if applicable. Please note that candidates belonging to OBC category have to submit the **latest financial year** OBC (non-creamy layer) certificate in Centre Government format to be produced by OBC applying for appointment to posts under Govt. of India.
 - 3. Candidates whose documents would be found in order as per eligibility criteria mentioned in the Advertisement, they shall be provided Offer of Appointment on the same day.

- 4. Subsequently on the next day the candidate shall report to Company Nominated hospital for Medical Examination.
- 5. Please note that a definite order of appointment indicating the date and place of reporting to duty shall be issued on being found medically fit.
