- (iii) Certificate in support of claim of belonging to Schedule Caste, Schedule Tribe and Other Backward Classes, EWS, where applicable in prescribed format as per Government of India's guidelines.
- (iv) If the candidate belongs to OBC, a caste certificate issued in the current financial year only by a competent authority as applicable for appointment to the services in Govt. Of India. Please note that an OBC certificate issued in the current financial year only can be accepted as a current proof of your not belonging to "creamy layer" in the OBC.
- (v) One Photo-identity-card like Aadhaar Card, Driving-license, Passport or any other valid document with you for identification.

- **4.** Candidates, who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion factor as applicable to percentage as prescribed by the University/Institute.
- **5.** Failure to adhere to above may lead to cancellation of the candidature. No claim whatsoever in case of cancellation of candidature (due to non-adherence as mentioned above) shall be entertained.
