5. Candidature of selected candidates is purely provisional subject to subsequent verification of original documents and also fulfilling the eligibility conditions as advertised. After document verification, the offer letter shall be issued to the eligible candidates.
6. All shortlisted candidates as per the Annexure-I & Annexure-II are requested to bring the following **original testimonials**, along with a set of self-attested photocopy for document verification as per the schedule.
 - (i) Six Copies of Passport Size Photograph.
 - (ii) Medical Fitness Certificate to be certified by Medical Officer not below the rank of an Assistant Surgeon or above. **(Annexure –III)**
 - (iii) Duly Signed Declaration Form. **(Annexure IV)**
 - (iv) Copy of registration/enrolment generated by Government website “www.mhrdnats.gov.in” as “STUDENT”
 - (v) Matriculation Certificate (for age proof),
 - (vi) Degree and Mark sheets of all the semester of Minimum Education Qualification (MEQ) prescribed in the Advt. A 01/2022.
 - (vii) Certificate in support of claim of belonging to Schedule Caste, Schedule Tribe, EWS and Other Backward Classes where applicable **in prescribed format as per Government of India's guidelines.**
 - (viii) **If the candidate belongs to OBC**, a caste certificate issued in the current financial year only by a competent authority as applicable for appointment to the services in Govt. Of India. Please note that an OBC certificate issued in the current financial year only can be accepted as a current proof of your not belonging to “creamy layer” in the OBC.
 - (ix) One Photo-identity-card like Aadhaar Card, Driving-license, Passport or any other valid document for identification.
7. Candidates, who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion factor as applicable to percentage as prescribed by the University/Institute.
8. Failure to adhere to above may lead to cancellation of the candidature. No claim whatsoever in case of cancellation of candidature (due to non-adherence as mentioned above) shall be entertained.

General Instructions:

- (i) The candidates are once again advised to check their eligibility thoroughly before appearing for document verification to avoid disappointment at later stage. If any discrepancies are found at any stage, the candidature of the candidate will be immediately cancelled.
- (ii) IRCON shall be free to reject any application at any stage, if the candidate is found ineligible for the respective post. The decision of IRCON in all matters regarding eligibility of the candidates at all stages of selection and any other matter relating shall be final. No correspondence or enquiries shall be entertained by IRCON, in this regard.

- (iii) **The candidates are advised to make necessary arrangements for his/her Travelling/Stay/Lodging on their own. No reimbursement of Air/Rail/Roadways fare / TA/DA will be done by IRCON.**
- (iv) IRCON will not entertain any request for change of date and time schedule of document verification.
- (v) If any of the particulars stated by candidate in the application on verification is found to be incomplete or incorrect or if you are found to have willfully suppressed any material fact/information relevant to the consideration of your case without prejudice to any other action that may be taken in consequence thereof, your candidature will be summarily rejected.
- (vi) IRCON reserves the right of postponing or deferring the date(s) of document verification for which necessary intimation will be sent to you in this case.
- (vii) Canvassing in any form by or on behalf of a candidate will be a disqualification.

MEDICAL FITNESS PARAMETERS
(As per Apprentices Act, 1961, SCHEDULE-II. (See Rule 4))

Standards of Physical Fitness for Training

1. A candidate should be free from evidence of any contagious or infectious disease. He should not be suffering from any disease which is likely to be aggravated by service or is likely to render him unfit for service or endanger the health of the public. He should also be free from evidence of tuberculosis in any form active or healed.

2. Height, Weight and Chest

Candidate should satisfy the following minimum standards, namely:

Height: 137 Centimeter

Weight: 25.4 Kilograms

Chest: Chest expansion should not be less than 3.8 Centimeters irrespective of size of the Chest.

Provided that where a candidate does not satisfy the said minimum standards but is certified, in writing. By a Medical Officer not below the rank of an Assistant Surgeon (Gazetted) to be physically fit for being engaged as an apprentice in that trade.

3. Eyes

There should be no evidence of any morbid condition of either eye or of the lids of either eye which may be liable to risk of aggravation or recurrence.

STANDARD OF VISION

(A) Visual acuity:

The minimum standard of vision acuity for all trades shall be:

6/18 in each eye or

6/12 in one eye and 6/24 in the other eye without glasses or

6/9 with glasses in both eyes.

Candidate with vision in one eye only shall be rejected.

4. Ears

Hearing must be good in both ears and there should be no sign of supportive disease.

No hearing aid shall be permitted.

5. Skin

There should be no evidence of acute or chronic ulceration.

MEDICAL FITNESS PARAMETERS

(As per Apprentices Act, 1961, SCHEDULE-II. (See Rule 4))

6. Speech

Speech should preferably be without impediment.

7. Alimentary System

- a. Candidate should have sufficient number of natural teeth (in healthy state) for mastication.
- b. Spleen should not be palpably enlarged and there should be no evidence of tenderness in the splenic area.
- c. Liver should not be palpably tender.
- d. There should be no oral sepsis.
- e. There should be no sugar in urine.
- f. Candidate should not be suffering from hemorrhoids, fissures in and testis anal hernia or bubonocoele or ischio-rectal abscess or hydrocele.

8. Cardio-vascular system

- a. Blood pressure should not exceed 85 diastolic and 140 systolic.
- b. Candidates with low blood pressure (i.e. systolic below 100) should be rejected.
- c. There should be no sign of any cardio-vascular disease.

9. Respiratory system

Candidate should be free from all disease of respiratory system, there should be no deformity of chest which may cause impediment to breathing.

10. Genitor-Urinary system

There should be no evidence of genitourinary disease or any abnormality.

11. Skeletal system

- a. The function of all limbs should be within normal limits.
- b. There should be no evidence of serious deformity of the Spinal Column or of the extremities.

12. Nervous system

There should be no evidence of any disease of nervous system or of any mental disease.

13. Glandular system

There should be no evidence of tuberculosis or other disease of the glandular system including the endocrine glands.
