- a. Stenography Test for English & Hindi 90 marks
- b. Computer Test 60 marks

Total Duration: 02 hours; Total Marks: 150 marks

The minimum qualifying marks are 60% and the skill test will be of qualifying nature only. Further, the candidate who will qualify the Skill test will only be shortlisted for further selection process, i.e., Interview.

All Provisionally Shortlisted candidates as per the table A(I) above are requested to bring their following original testimonials, along with a photocopy set, for document verification on the day of Skill Test as per the schedule above:

- (i) Matriculation Certificate (for age proof);
- (ii) Certificate & Marksheets of essential qualification (Professional/academic Degree/diploma) as prescribed in advertisement. Also, necessary documents specifying the CGPA equivalence or CGPA to percentage conversion documents, wherever applicable.
