 - (iv) **If the candidate belongs to OBC**, a caste certificate issued in the current financial year only by a competent authority as applicable for appointment to the services in Govt. Of India. **Please note that an OBC certificate issued in the current financial year only can be accepted as a current proof of your not belonging to “creamy layer” in the OBC.**
 - (v) One Photo-identity-card like Aadhaar Card, Driving-license, Passport or any other valid document with you for identification.

4. Candidates, who have been awarded CGPA/OGPA/DGPA in place of marks in degree, should submit proof of conversion factor as applicable to percentage as prescribed by the University/Institute.
5. Failure to adhere to above may lead to cancellation of the candidature. No claim whatsoever in case of cancellation of candidature (due to non-adherence as mentioned above) shall be entertained.
6. As per Clause A-10 of the aforesaid advertisement, **the eligible candidates will be shortlisted on the basis of merit list formed on the basis of marks secured in Minimum Educational Qualification”.**
